- 4. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egpon or before 12:00 Noon on 2078/02/05. Bids received after this deadline will be rejected.
- 5. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 13:00 on 2078/02/05 at the office of Namobuddha Municipality, Office of the Municipal Executive. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1,50,000, which shall be valid for 30 days beyond the validity period of the bid.
- 6. Buffalo(Female) should be delivered and transported to the specified place as requested by Namobuddha Municipality.
- Buffalo(Female) should be delivered after health examination by authorized technician authorized by Namobuddha Municipality.
