Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

4. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp or before **12:00 Noon on 2078/02/05**. Bids received after this deadline will be rejected.
5. The bid will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2078/02/05** at the office of **Namobuddha Municipality, Office of the Municipal Executive**. Bids must be valid for a period of **120 days** from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 1,50,000**, which shall be valid for 30 days beyond the validity period of the bid.
6. Buffalo (Female) should be delivered and transported to the specified place as requested by Namobuddha Municipality.
7. Buffalo (Female) should be delivered after health examination by authorized technician authorized by Namobuddha Municipality.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Namobuddha Municipality reserves the right to accept or reject, wholly or partly any or all the Sealed Bid without assigning any reason, whatsoever.
10. Matters not cover by this notice shall be in accordance with Public Procurement Act-2063 with amendment, Public Procurement Regulation-2064 with amendment and other prevailing laws.
