- The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM** on **2077/12/05 (18<sup>th</sup> March, 2021)** at the office of **Namobuddha Municipality, Kavre**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs. 55,000** which shall be valid for 30 days beyond the validity period of the bid.
